



## Insurance Act No. 18 of 2017

### Notice of the variation of licensing conditions in terms of section 26 of the Insurance Act, 2017 (Act No. 18 of 2017): The Hollard Insurance Company Limited

I, Fundi Tshazibana, with the concurrence of the Financial Sector Conduct Authority, and acting under section 126(1)(a) of the Financial Sector Regulation Act, 2017 (Act No.9 of 2017) (FSRA) read with section 26(1)(a) and 26(4) of the Insurance Act, 2017 (Act No.18 of 2017) (the Insurance Act), hereby give notice of the variation of licence conditions of The Hollard Insurance Company Limited (THIC) which is a Non-Life Insurer.

In terms of this notice, the classes and sub-classes of non-life insurance business that THIC is currently licensed to conduct are hereby varied to include:

- (i) The varied licensing conditions came into effect on 17 May 2026.
