Publication of Prudential Standard RA04 - Requirements for Valuers Appointed for Resolution Purposes

Objective of this Prudential Communication

This communication serves to inform stakeholders of the publication of the Prudential Standard RA04 - Requirements for Valuers Appointed for Resolution Purposes. The Standard is issued in terms of section 105 of the Financial Sector Regulation Act, 2017 (Act No. 9 of 2017)(the Act).

1. Application

- 1.1 This Prudential Communication applies to all designated institutions as defined in the Act and valuers conducting valuations for resolution purposes as contemplated in section 166Q of the Act.

2. Purpose

- 2.1 The purpose of this Prudential Communication is to notify all designated institutions and potential valuers of the publication of the Prudential Standard RA04 - Requirements for Valuers Appointed for Resolution Purposes.
- 2.2 The Prudential Standard is made in terms of section 105(2)(c) read with sections 30(1A)(a)(ii), and 166Q of the Act.

3. Background and implementation date

- 3.1 The Standard sets out the requirements for valuations conducted for resolution purposes that must be complied with by all valuers.
- 3.2 The Standard comes into effect on the date of publication on the website of the Prudential Authority.
