Dit is toe te skryf aan die feit dat die valutaverlies en -wins as gevolg van die devaluasie van sterling en sekere ander geldeenheidse in November 1967, die revaluasie van die Duitse mark in Oktober 1969 en die aanvanklike toekennung van spesiale trekkingsregte in Januarie 1970, vir doeleindes van hierdie tabel buite rekening gelaat is ten einde die beweging van kapitaal meer korrek weer te gee.

1. The changes in this item for the fourth quarter of 1967, the year 1967, the fourth quarter of 1969, the year 1969 and the first quarter of 1970, do not fully agree with the changes shown for the corresponding periods in the last column of table S-57. This is attributable to the fact that, in order to indicate capital movements more correctly, the exchange losses and profits incurred as a result of the devaluation of sterling and certain other currencies in November 1967, the revaluation of the German mark in October 1969 and the initial allocation of special drawing rights in January 1970, were not taken into account for purposes of this table.
