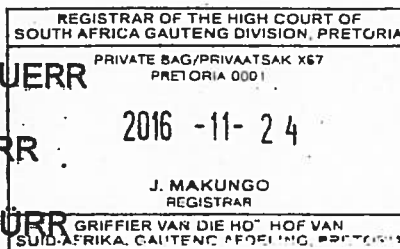

THEREAFTER ON THIS DAY THE COURT ORDERS

JUDGMENT

1. Prayers 1, 2 and 3 of the Notice of Motion are granted as against respondents, one to 11 and 17 to 28.
 1. Directing the respondents to dispose of those Reserve Bank shares, which they hold in aggregate with their associates, in excess of 10,000.

2. Appointing Investec Securities Proprietary Limited to act as an independent broker to facilitate the disposal of those shares over a period of two (2) years from the date of this order, at a sale price of not less than R1,55.
 3. Directing the General Counsel of the applicant to do all things necessary to enable the sale of the shares referred to in prayer 1 above, including signing all necessary documentation and providing whatever assistance is necessary to independent broker referred to in prayer 2 above.
2. No order as to costs is made.
