JUDGMENT

- 1. Prayers 1, 2 and 3 of the Notice of Motion are granted as against respondents, one to 11 and 17 to 28.
 - 1. Directing the respondents to dispose of those Reserve Bank shares, which they hold in aggregate with their associates, in excess of 10,000.

- 2. ppointing Investec Securities Properietary Limited to act as an independent broker to facilitate the disposal of those shares over a period of two (2) years from the date of this order, at a sale price of not less than R1,55.
- 3. Directing the General Counsel of the applicant to do all things necessary to enable the sale of the shares referred to in prayer 1 above, including signing all necessary documentation and providing whatever assistance is necessary to independent broker referred to in prayer 2 above.
- 2. No order as to costs is made,
