**Exchange Control Circular No. 37/2015**

**Authorised Dealer in foreign exchange**

The attention of Authorised Dealers is drawn to Government Notice No. 1295 published in Government Gazette No. 39573 of 2015-12-29 in terms of which Canara Bank is appointed as an Authorised Dealer in foreign exchange.

In addition to the necessary amendments to the Orders and Rules under the Exchange Control Regulations, 1961, the name Canara Bank must be added to the list of Authorised Dealers in foreign exchange in Section A.2(A) of the Exchange Control Rulings.

The relevant Government Notice and replacement page of the Exchange Control Rulings incorporating the amendment are attached hereto.


