## **Exchange Control Circular No. 7/2025**

### **Amendment of the name Old Mutual Bank Limited to OM Bank Limited as a Restricted Authorised Dealer in foreign exchange**

The name of Old Mutual Bank Limited has been corrected to OM Bank Limited as a Restricted Authorised Dealer in foreign exchange with immediate effect. It follows, therefore, that the name Old Mutual Bank Limited will be removed and replaced with OM Bank Limited in the list of Restricted Authorised Dealers in sections A.2(C) and A.2(A) of the Currency and Exchanges Manual for Authorised Dealers in foreign exchange with limited authority and the Currency and Exchanges Manual for Authorised Dealers (Manuals), respectively, as well as the guideline documents for business entities and individuals (guideline documents).
