Amendment of the name Tyme Bank Limited to GoTyme Bank Limited as a Restricted Authorised Dealer

Tyme Bank Limited, currently authorised as a Restricted Authorised Dealer, has changed its name to GoTyme Bank Limited. It follows, therefore, that the name of Tyme Bank Limited will be removed and replaced with GoTyme Bank Limited in the list of Restricted Authorised Dealers in sections A.2(A) and A.2(C) of the Currency and Exchanges Manual for Authorised Dealers and the Currency and Exchanges Manual for Authorised Dealers in foreign exchange with limited authority (Manuals), respectively.
