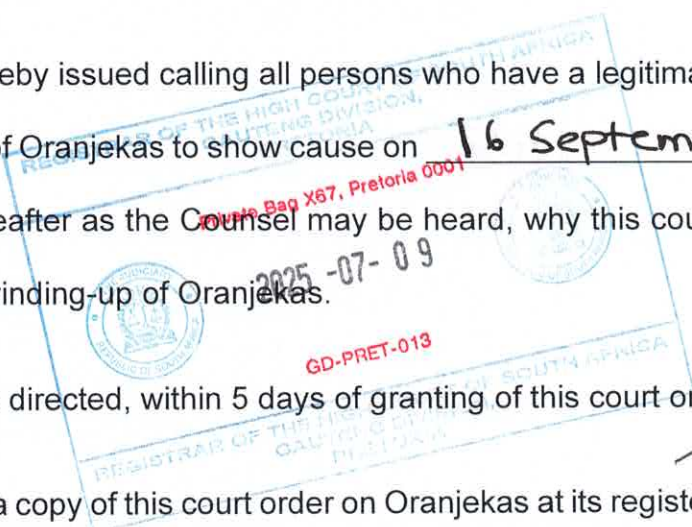
**ORDER**

**HAVING** heard counsel for the applicant and having read the pleadings filed of record,  
the court makes the following orders :

1. This application is enrolled as an urgent application in terms of Rule 6(12) of the Uniform Rules of Court.

2. The Respondent, Oranjekas Savings and Credit Co-Operative Limited ("Oranjekas"), is hereby placed under provisional winding up. *its section 40F Co-operative Banks Act 40 of 2007-*
3. Mr Zaheer Cassim (of Cassim Trust Insolvency Practitioners) is hereby appointed as the provisional liquidator of Oranjekas. *its section 40F(2) of Co-operative Banks Act 40 of 2007-*
4. The Master of the High Court, Pretoria is directed to appoint Mr Zaheer Cassim as the provisional liquidator of Oranjekas within 48 hours of this court order.
5. A *rule nisi* is hereby issued calling all persons who have a legitimate interest in the winding up of Oranjekas to show cause on 16 September 2025 or so soon thereafter as the Counsel may be heard, why this court should not order the final winding-up of Oranjekas.
6. The Applicant is directed, within 5 days of granting of this court order:
  - 6.1 to serve a copy of this court order on Oranjekas at its registered address;
  - 6.2 to take steps to cause this court order to be published (i) on the Applicant's official website, (ii) in one issue of the Government Gazette, and (iii) in one issue of each of the Citizen and Star newspapers;
7. Should the Respondent or any other interested party wish to oppose or support the final winding up of the Respondent, such party must, by 12 August 2025, file their respective affidavit with the Registrar of the Court and serve copies thereof on the Applicant's attorneys, Werksmans Attorneys, at The Central, 96 Rivonia Road, Sandton.
8. Costs of this application are to be the costs in the final winding-up.
