I. INTRODUCTORY REMARKS

1. Purpose of sector classification

The Institutional Sector Classification Guide for South Africa divides institutions into institutional sectors as suggested by the 1993 System of National Accounts (1993 SNA) for the analysis of economic transactions. An alternative classification system, the Standard Industrial Classification of all Economic Activities or SIC, will be discussed in Schedule A.

The Research Department of the South African Reserve Bank collects financial data, in respect of the major institutional sectors, on a regular basis from financial institutions, such as banks, insurers and pension funds, as well as from other organisations such as public corporations and local authorities. This information is used, inter alia, for analysing the flow of funds between sectors, establishing which sectors require which types of financing and which sectors provide in these particular needs. Thus, in the case of an issuer of stock, for example a public corporation such as ESKOM, it is important to know from which sectors of the economy subscriptions are received for the new stock issue, and also to keep track of transactions in which such existing securities are traded between sectors.

Due to the numerous individual organisations and persons that are economically active, it is necessary to make meaningful groupings or sector classifications of the parties involved. It is therefore the purpose of this institutional sector classification to serve as a guide in this respect for the organisations rendering financial survey returns to the Research Department of the Reserve Bank.

The list of public corporations, in the sector for public enterprises, namely sector 12 from page 28, also serves as the reference list of "public corporations" for the purposes of the regulations promulgated in terms of the Mutual Banks Act (No. 124 of 1993) and the Banks Act (No. 94 of 1990), respectively.



Companies registered under the Close Corporations Act, (69/1984), and which are obliged to incorporate the words "CC" and their number as the last words in their name.

11.5 Other private sector companies

All other companies in the private sector registered under the Companies Act (that is, organisations which are required by law to incorporate the abbreviation(s) "Ltd", "(Pty) Ltd" or "Inc" as the last word(s) in their names), but excluding banks, insurers, finance companies (see definition in 6.3), financial auxiliaries (see 6.5) and **associations not for profit** registered under Section 21 of the Companies Act. (See 13.3)

Non-financial controlling companies are also included in this group, whereas financial controlling companies are classified under 6.6.

SCHEDULE A

STANDARD INDUSTRIAL CLASSIFICATION OF ALL ECONOMIC ACTIVITIES (SIC)

The Institutional Sector Classification Guide for South Africa, as contained in the preceding pages, divides institutions into groups which are meaningful for the analysis of National Financial Accounts and emphasises the various types of financial institutions. An alternative classification system, the Standard Industrial Classification of all Economic Activities or SIC, is also frequently used to classify institutions. This system involves the classification of an institution on the basis of its principal class of goods produced or services rendered, in other words its industrial classification.

The SIC is a classification of economic activities of industries. An industry consists of establishments engaged in the same or a closely related kind of economic activity based mainly on the principal class of goods produced or services rendered. The term "industry" is used in the widest sense to cover all economic activity from the primary industries of agriculture, forestry, fishing and mining to the rendering of social, recreational, cultural and personal services.

Whereas the Institutional Sector Classification Guide for example distinguishes (non-financial) private sector companies as a group, the SIC would further subdivide these companies by type of economic activity, such as manufacturing, construction, etc. An analysis of the distribution of banks' loans, advances and discounts by SIC major divisions is important for sound risk management, and is supplied to the Registrar of Banks by banks on their DI 500 returns.

The major divisions of the SIC are as follows:

- 1. Agriculture, hunting, forestry and fishing
- 2. Mining and quarrying
- 3. Manufacturing
- 4. Electricity, gas and water supply
- 5. Construction
- 6. Wholesale and retail trade; repair of motor vehicles, motor cycles and personal and household goods; hotels and restaurants
- 7. Transport, storage and communication

- 8. Financial intermediation, insurance, real estate and business services
- 9. Community, social and personal services (including public administration, defence, education, health, etc.)
- 0. Private households, exterritorial organisations, representatives of foreign governments and other activities not adequately defined.

The code of the last major division is nil, not ten. Further subdivision is provided for in the SIC; on the most detailed level subgroups such as "Manufacturing of men's and boy's clothing" are distinguished, with five digit codes such as 31401.

When compiling a database of clients it may therefore be sensible to attach <u>two</u> classification codes to each client, one for its Institutional Sector class and one for its Standard Industrial class. By awarding an Institutional Sector class, non-residents are at the same time distinguished from residents of South Africa - a distinction which is of extreme importance.

THE TREATMENT OF INDIVIDUALS/HOUSEHOLDS IN THE SIC

Certain institutions, such as banks, have numerous individuals or households as clients. *Individuals who run their own unincorporated businesses* have an Institutional Sector Class code 13.2 and receive the SIC code of the relevant industry: as an example, a farmer who farms animals and also grows crops receives SIC code 11300.

If the institution wishes to allocate SIC codes to all its clients, problems arise in respect of those *individuals who do not run their own businesses*. Because the SIC is aimed at the *production* activities of industries, it does not provide for individuals or households as such. To handle this problem, it is suggested that institutions add the following grouping under major division 0 of the SIC:

Division 09, Other activities not adequately defined, is subdivided into two major groups:

Major group	Description
091	Individuals or households, not elsewhere contemplated, including individuals who are employees of other institutions, pensioners, unemployed persons, scholars, etc.
092	Other

SIC major group 091 will correspond with Institutional Sector Class 13.1.

Under SIC major group 091 the following groups and subgroups are provided for:

Group	Subgroup	Description
0911	09110	Employees of other institutions (not of an own business)
0912	09120	Pensioners/retired persons
0913	09130	Other individuals or households, including unemployed persons, scholars, etc.
